#### WHAT DOES PEOPLES STATE BANK (PSB) DO WITH YOUR PERSONAL INFORMATION?

How does PSB protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. How does PSB collect my personal information? Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial companies.  Our affiliates include: Financial Shares, Inc located in Hoxie, KS and Legacy Solutions Insurance, LLC located in Manhattan, KS.
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial companies.  PSB does not share with nonaffiliates so they can market to you.
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial products or services to you.  • PSB doesn't jointly market.
